Membership Application and Code of Ethics

The Lost Dutchman Kennel Club, Inc. is a working kennel club and members are encouraged to participate in club functions. The purpose of the club is:

- To further the advancement of all breeds of purebred dogs.
- To do all in its power to protect and advance the interest of all breeds of purebred dogs and to encourage sportsmanlike competition at dog shows and obedience trials.
- To conduct sanctioned matches, dog shows and obedience trials under the rules of The American Kennel Club.

In keeping with the club's purpose, members are expected to promote the sport of dogs in a positive manner in both club sanctioned events and in personal activities. While membership is to be unrestricted as to residence, the club's primary purpose is to be representative of the purebred dog owners, breeders and exhibitors in the Greater Apache Junction area. It is highly recommended that prospective members attend club meetings to get acquainted prior to submitting an application for membership.

Members must be in good standing with the American Kennel Club, Inc. and subscribe to the club's stated purpose. The types of memberships for persons who are age 18 or over include:

- Single: Enjoys all club privileges including the right to vote and hold office.
- Family: All persons in the household enjoy all club privileges including the right for each person 18-years-old and over in the household being entitled to one vote each for up to two total votes per household.
- Associate membership is open to persons who wish to support the work of the club but do not wish to be voting members.

Youth membership is open to any person who is under 18-years-old. Youth members pay dues and enjoy all club privileges except the right to vote. They they are eligible to serve in an advisory capacity to the Board of Directors.

Membership applications must have the signatures of two current club voting members in good standing (these cannot be persons residing in the same household). Membership applications must include payment for dues in order to be considered. Applications will be read at the first general meeting of the club after receipt of the application and dues by the secretary. A second reading will occur at the next general meeting and an affirmative vote of two-thirds of the members present and voting shall be required to accept the applicant.

Monthly Club meetings are held on the third Monday of each month. Information on location of the meetings can be found at www.ldkc.org and on the Club's Facebook page, Lost Dutchman Kennel Club.

3. **SALES.** Canines will not be sold to sources of commercial distribution such as, but not limited to, pet stores, wholesalers, pet dealers or brokers, and catalogue houses. Canines will not be supplied for raffles, "give-away" prizes or similar fund-raising projects.
4. **ADVERTISEMENT.** Oral and/or written advertisement of canines will be factual both in substance and implication. It will be limited to the dog fancier's canines and will in no way degrade the canines of others.
5. **HOUSING OF CANINES.** Canines will be kept under sanitary conditions, afforded health care and protection and transported in a safe manner.
6. **MEMBER RELATIONS.** Each member or associate will be obligated to protect the interests of the club and purebred dogs in a manner reflecting the interests of the club and purebred dogs in a manner reflecting credit upon the individual, the sport of purebred dogs and the club.

The Board of Directors will adopt a procedure for review of violations of the CODE OF ETHICS and this procedure will be guided by the following policies:

- no anonymous complaints will be considered;
- no complaint will be considered unless it is reported in writing to the Board designated recipient within fourteen (14) calendar days of the infraction;
- sanctions imposed may include: cancellation of membership or associate status for an indefinite or specified period; cancellation or suspension of the privilege to participate in club activities and sponsored events for an indefinite or specified period; written reprimand and/or verbal reprimand;
- in no case will membership dues and/or any participation fees, or any portion thereof, be refunded to an individual whose membership and/or participation privileges is/are rescinded; and,
- the decision of the Board of Directors in the review of a complaint is final.
